Community Foundation appoints prominent business leader to board

Ruffner Page has been named chairman of the board of directors of the **Community Foundation of Greater Birmingham**.

The state's oldest and largest community foundation also added two new board members with terms starting this year – Judge William "Bill" Hereford and Susan Matlock.

Page has worked his way up with **McWane Inc.** since 1993 and has been president since 1999. Prior to McWane, he was in management at **National Bank of Commerce**, the Remington Fund and Bankers Trust Company in New York and Atlanta.

He currently serves on the boards of directors of McWane Inc., Southern Research, National Commerce Corporation, CorMatrix, O'Neal Industries, Birmingham Airport Authority, Birmingham Education Foundation, the **Birmingham Museum of Art** and the **Alabama Symphony Orchestra**. He is also involved with the Downtown Rotary Club, **Leadership Birmingham** and Leadership Alabama.

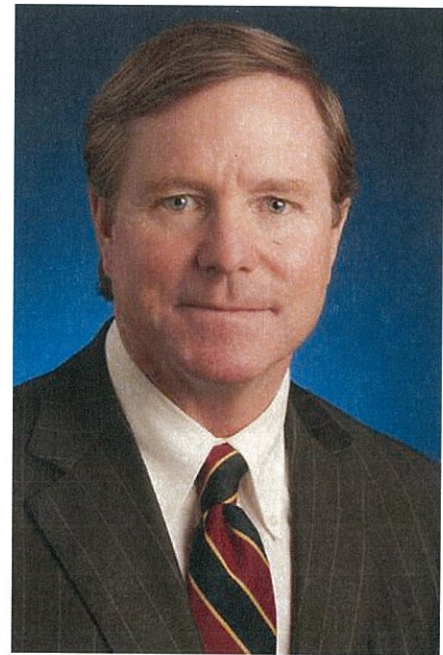

Hereford is a senior circuit judge and former presiding judge of the Thirtieth Judicial Circuit of Alabama. He is also involved with the Rotary Club of Pell City, Leadership St. Clair County, Leadership Alabama, the American Legion, the Jefferson State College Advisory Board and the Alabama Care Plan Citizens' Advisory Committee.

Hereford was previously mayor of Pell City, chairman of Brownell Travel, chairman of St. Clair County Head Start, chairman of St. Vincent's St. Clair Hospital Advisory Board and president of the St. Clair County Bar Association. He has served on the boards of the Cultural Alliance, Literacy Council of

Central Alabama and the Alabama Board of Bar Commissioners. In 2012 he received the Man of Valor Award from the YWCA of Central Alabama for his work on behalf of domestic violence victims.

Matlock is the former president and chief executive officer of Birmingham's Innovation Depot, a biotechnology and information technology incubation center. She began her career as a banker, lending to small businesses and consumers and has been recognized by the U.S. Small Business Administration as the Financial Services Advocate of the Year for the state.

Matlock currently is involved with the Blue Cross/Blue Shield of Alabama and Regions Financial Corporation boards of directors. She also has served as chairman of the Board of Directors of the **National Business Incubation Association**. Innovation Depot was named 2011 "Technology Incubator of the Year" by NBIA, which has members from 66 nations. She has been an active member of leadership, educational and civic organizations.
